

Advice and Guidance for Suspensions

My child has been suspended - but what does this mean and what do I need to do about this?

What does the law say?

This government supports headteachers in using suspensions and permanent exclusions as sanctions to manage student behaviour and create a calm, safe and supportive environment which is safe and free from disruption and fear of bullying.

Schools can suspend a student for a specific period, known as a fixed-term suspension, up to a maximum of 45 school days in a single academic year. Suspensions can be for a part of a day or multiple periods, but the total cannot exceed the 45-day limit. A suspension is for a disciplinary reason and the headteacher must consider any contributing factors to the behaviour, like home circumstances or bullying.

Additional information

- Only the headteacher of a school can suspend a pupil on disciplinary grounds. The policy on this must be published on the school's website.
- When Headteachers suspend a pupil, they must, without delay, notify the child's parent or carer and the local authority. If a pupil has a Social Worker or if a pupil is a Child in Care, the Headteacher must immediately notify the Social Worker and the Virtual School Headteacher.
- A Headteacher can issue a suspension in response to a child's behaviour that breaks the rules, in or outside of school.
- Pupils with special educational needs (SEN) or a
 disability can be suspended from school. The law does
 not prevent a child from receiving a sanction for
 misbehaviour, but schools do have a legal duty, under
 the Equality Act 2010, not to discriminate against
 children because of a disability. Schools are not
 allowed to suspend a pupil because they have a
 disability or additional needs the school cannot meet.
- Schools must set & mark work for the first five school days of a suspension.
- Schools cannot simply send a child home for 'cooling off'. This is an unlawful exclusion.
- Following a school suspension, a reintegration meeting
 is crucial for a smooth return to school. It's a chance for
 the school, the pupil and their parent or carer to
 collaborate on strategies to prevent future suspensions
 & ensure the pupil's successful return to learning & the
 school community.

Key questions you may want to consider:

- What does being suspended from school mean exactly?
- Can I appeal the school's decision to suspend my child?
- Was my child asked why they behaved in such a manner?
- What work will school provide for the period of my child's suspension?
- Can I ask for the specific details about the incident that led to the suspension?
- How long is my child suspended for?
- During the period of suspension, can my child be out and about in the community?
- Will my child's suspension go on his school record?
- Are there any support services that can support my child through this?
- Was my child's special educational needs (SEN) taken into account when a suspension was being considered?
- When will my child's reintegration meeting be held?
- When my child returns to school & to reduce the likelihood of another suspension, how will my child be supported to manage their behaviour?
