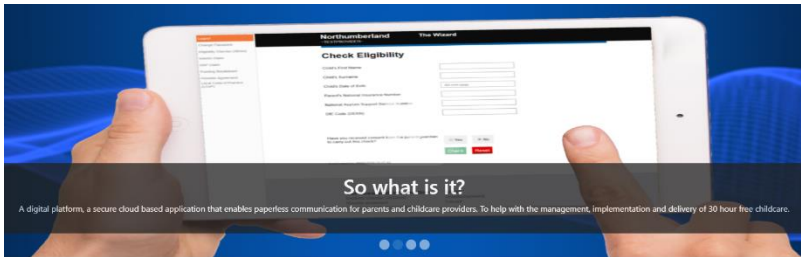


How to submit your Interim Payment Claim (previously via SharePoint)

To claim interim funding you can now do this in the Wizard system. This guide will take you through the steps to submit your claim.



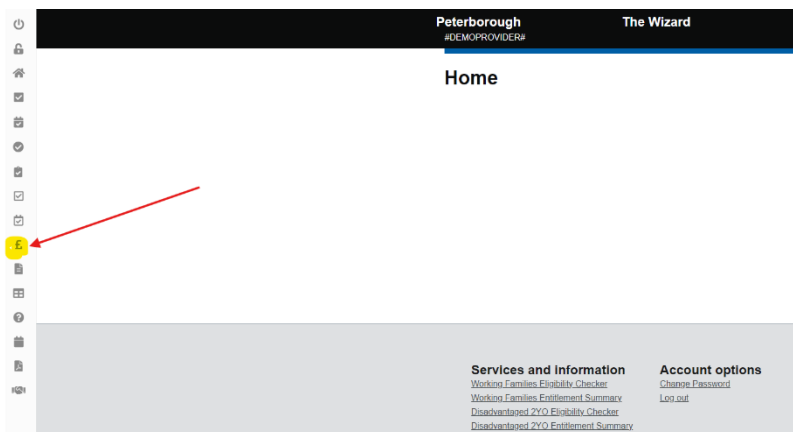

1. Login using the web address above. You need your Provider reference (establishment number); user name (usually firstname.surname) and your password. If you need help or to reset your password email nurseryeducationfunding@peterborough.gov.uk



2. You may be asked to sign the Code of Practice if someone at your setting has not already done so on Wizard. This is to confirm you have signed up for EY funding – this is already completed through your provider agreement which will have been signed by the appropriate person for your setting, so please accept to progress. On the left-hand menu select Payment Claim.

4. Please note the deadline for claim. If you miss this then you **will not be paid on the first pay date in your Key Dates section** and you will not receive a payment until after headcount.

You can vary the percentage interim payment up to a maximum of 75% using the green slider.

The first section is Number of children with 2YO funding – this is the Disadvantaged 2 YO funding. Make sure you have a valid code for this (on a letter or email from the issuing Local Authority to the parent)

5. **Number of funded children** – Enter the number of children eligible for disadvantaged 2 YO funding that are you claiming

Average Weekly Hours per child (max 15 hours) - This an average. For example - three children doing 15hrs and one child doing 8hrs20mns (8.33hrs) average $(15 \times 3) + (8.33) = 53.33$ divided by 4 children = 13.33

Hourly rate and no. weeks in term are pre-populated and term time equivalent.

6. **Total Claim (term)** – this is the total value of 100% of your claim for this funding stream

Estimated Payment – The value of the payment you can expect (either 75% up front or the 25% monthly payment)

- The provider operates under a single registration for a minimum of 50 weeks per year (not including bank holidays) and is open continuously for more than seven hours per day

Or

- The provider operates for less than 50 weeks but more than 40 weeks per year and is open for a minimum of ten hours per day.

In addition to meeting this criteria children must regularly be attending the provider each week the provider declares itself open and at the very beginning and end of each day. They must also be able to access continually through the day during opening hours, with no closure at lunch. The Provider should also actively promote the stretch entitlement to families accessing the provision.
